MAJESTIC-MIRROR MEMBERSHIP RIGHTS AND OBLIGATIONS

Membership Rights. Members in good standing shall be entitled to the following rights, interests, and privileges of Majestic-Mirror Membership:

- Access to two award-winning golf courses
- No Initiation Fee
- Prepaid green fees & cart fees
- Seven-days-in-advance tee times (subject to availability) – please note the public may make only three days in advance tee times
- GHIN Handicap Systems (each location)
- Use of pre-designated club facilities such as locker rooms, swimming pool, etc.
- Membership to Majestic Fitness Facility (state-of-the-art, weight resistance, cardio, etc.)
- Special leagues and events catering to Members such as Men's Association, Ladies' Association, tournaments, leagues, parties and socials
- 10% off regularly priced Pro Shop merchandise
- 50% off regularly priced Practice Range tokens
- Discounted fees at other select golf courses under reciprocity programs
- Reduced greens fees and cart fees for guests
- Discounted club repair and customized club fitting

Policies for Play. Members shall abide by all Majestic-Mirror Policies of Play. Majestic Golf Club and Mirror Lakes Golf Club are soft spike facilities – no metal spikes are permitted. All golfers, including members, must check in at the Pro Shop before playing golf. Slow play is prohibited and players may be asked by course rangers to move forward or to allow faster players through. No beverages or beverage coolers, other than those purchased or provided by Majestic-Mirror, are allowed on the course. Each golfer must have his/her own set of golf clubs – rental clubs are available for a fee in the Pro Shop. No more than two golfers may ride in a golf cart at any time. When only two golfers are in a group, they must share one golf cart. A valid driver's license is required to operate a golf cart. The 90-degree rule is always in effect. Driving vertically down fairways is prohibited. Carts must be driven in the rough, and then may cross into the fairway at a 90-degree angle. Golf carts may not be driven in front of greens and must be 30-feet away from greens and tee boxes at all times (handicapped drivers are exempt from this rule). Majestic-Mirror management or their designated representatives (i.e., golf course rangers) have full authority to enforce these policies of play. Violators are subject to loss of playing privileges. **Any member that cannot make a scheduled tee time must cancel it within 24-hours prior to scheduled tee time to retain the privilege of scheduling any future 7 days in advance tee times.**

Dress Code. Proper golf attire is required at all times. For **men**, slacks or Bermuda length shorts must be worn. Polo or long sleeve shirts with a collar or mock turtleneck are required. For **women**, slacks, skirts, or Bermuda length shorts must be worn. Ladies are permitted to wear sleeveless shirts so long as they have a collar or mock turtleneck. In other words, all shirts without a collar must have either short or long sleeves. Jeans, denim, sweat pants, bathing suits, running shorts, tank tops, and midriff skirts are not permitted. The dress code is mandatory – members or their guests who are improperly dressed will be asked to change or leave the premises. If you have doubts about any particular piece of attire, please ask the Pro Shop staff.

Payment of Fees. Members shall pay all membership fees in full by the assigned date. A monthly penalty of fifty dollars (\$50.00) will be charged and added to any delinquent membership balances. Majestic-Mirror management, or their designated representative, shall, upon the first day of each calendar month, or soon thereafter as may be practicable, notify each Member of their indebtedness to Majestic-Mirror by use of Majestic-Mirror's customary billing statement. If, in the opinion of Majestic-Mirror management, a Member's indebtedness becomes excessive, Majestic-Mirror management shall have the power to suspend the delinquent Membership, including the use and enjoyment of Majestic Golf Club and Mirror Lakes facilities. If the indebtedness of any delinquent Member who's Membership has have been suspended remains unpaid for 30 days following notice of suspension, the Membership of such delinquent Member may be terminated by Majestic-Mirror management.

Membership Termination. Membership of any Member of Majestic-Mirror may be terminated by death, resignation, or expulsion. Termination of Membership shall operate as a release of all rights, interests, and privileges of Majestic-Mirror membership. If, in the opinion of Majestic-Mirror management, the reported activities, conduct, or reputation of any Member at any time or any place (whether on or off Majestic or Mirror premises) is such that may reflect adversely on the reputation, character, or good standing of Majestic Golf Club or Mirror Lakes Golf Club, management shall have the power to require the Member to resign, be censured, or to expel and terminate such Member's Membership or privileges, or take any other course of action Majestic-Mirror management deems proper under the circumstances. If a member holding a family membership passes away / becomes deceased prior to September 30, his/her spouse will receive a credit towards his/her membership for the following golf season.

Membership Assignment or Transfer. Membership with Majestic-Mirror shall not be assignable or transferable by any Member, nor shall any rights, privileges or powers of

Members be transferable or assignable, except as approved in writing by Majestic-Mirror management.

Liability. Majestic Golf Club and Mirror Lakes Golf Club shall not be liable or responsible for the destruction, loss, or damage to, the property of any Member or guest. The Member is responsible for any and all Majestic-Mirror property that is injured, damaged, or removed by the Member, or by any guest or other person for whom the Member is responsible, and shall compensate Majestic-Mirror for such injury, damage, or removal in an amount determined by Majestic-Mirror management.

Entitlements. Majestic Golf Club and Mirror Lakes Golf Club are privately owned entities. Majestic-Mirror members do not have any voting privileges, ownership interests, or equity. All members must abide by all rules and regulations set forth by Majestic Golf Club and Mirror Lakes Golf Club.
