POOL & FITNESS MEMBERSHIP RIGHTS AND OBLIGATIONS

Membership Rights Members in good standing shall be entitled to the following rights, interests, and privileges of Majestic-Mirror Social Membership which includes the use of pre-designated club facilities including enclosed/screened-in pool, fitness facility, and locker rooms.

Social Membership Rules Members shall abide by Majestic-Mirror Pool & Fitness Membership Policies. Members are responsible for the actions of their guests and any damage that they may cause. The following social membership rules must strictly be followed:

Fitness facility No users under 18 years of age unless accompanied by an adult. No food or drink (other than water) is allowed. Please put weights and equipment back in their designated areas when finished.

Enclosed/Screened-In Pool NO DIVING. No users under 18 years of age unless accompanied by an adult. All pool users must shower/rinse off before entering. No food, drink or glassware is allowed in or within 10 feet of the pool. No animals are permitted in the pool or on the pool deck. The pool-use load is 16 persons.

Locker Rooms Social Members and their guests must be courteous to other Majestic-Mirror Members. They must pick up after themselves and not leave any items lying around the area.

Payment of Fees Members shall pay all membership fees in full by the assigned date. A monthly penalty of twenty-five dollars (\$25.00) will be charged and added to any delinquent membership balances. Majestic-Mirror Management, or their designated representative, shall, upon the first day of each calendar month, or soon thereafter as may be practicable, notify each Member of their indebtedness to Majestic-Mirror by use of Majestic-Mirror's customary billing statement. If, in the opinion of Majestic-Mirror Management, a Member's indebtedness becomes excessive, Majestic Management shall have the power to suspend the delinquent Membership, including the use and enjoyment of the facilities of Majestic-Mirror by the Member. If the indebtedness of any delinquent Member who's Membership shall have been suspended remains unpaid for 30 days following notice of suspension, the Membership of such delinquent Member may be terminated by Majestic Management.

Membership Assignment or Transfer Membership at Majestic-Mirror shall not be assignable or transferable by any Member, nor shall any rights, privileges or powers of the Members be transferable or assignable, except as approved in writing by Majestic-Mirror Management.

Membership Termination Membership of any Member of Majestic-Mirror may be terminated by death, resignation, or expulsion. Members who are paid in full and who resign their Membership are entitled to a partial refund on a per quarter basis: \$15 per quarter for Single Memberships and \$30 per quarter for Family Memberships. Termination of Membership shall operate as a release of all rights, interests, and privileges of Majestic-Mirror Membership. If, in the opinion of Majestic-Mirror Management, the reported activities, conduct, or reputation of any Member at any time or any place (whether on or off Majestic-Mirror property) is such that may reflect adversely on the reputation, character, or good standing of Majestic-Mirror, Management shall have the power to require the Member to resign, to censure, or to expel and terminate such Member's Membership or privileges, or take any other course of action Majestic Management deems proper under the circumstances.

Liability Majestic-Mirror shall not be liable or responsible for the destruction, loss, or damage to, the property of any Member or guest. The Member is responsible for all property of Majestic-Mirror injured, damaged, or removed by the Member, or by any guest or other person for whom the Member is responsible, and shall compensate Majestic-Mirror for such injury, damage, or removal in an amount determined by Majestic-Mirror Management.
